## National Academies of Sciences Hosts 2nd Meeting to Review MRIP

As part of its [current independent expert review](#) of the Marine Recreational Information Program (MRIP), the National Academies of Sciences' Ocean Studies Board will host a meeting at the Courtyard Charleston Historic District, 125 Calhoun Street in Charleston, South Carolina from April 25-26. This review is intended to provide an objective analysis of how well NOAA Fisheries has incorporated and acted on the recommendations in [the Academies' 2006 report](#).

The public is invited to attend and observe the open sessions. There will be an opportunity to provide brief oral comments during a 30-minute period on Tuesday, April 26.

This independent review, which started in September, 2015, will assess MRIP's current approach to developing and implementing statistically sound recreational fisheries data collection programs that meet the needs of stock assessment scientists, fishery managers, and stakeholders. Based on this assessment, the committee may recommend new directions or changes that could better address emerging needs for more timely and accurate monitoring of marine recreational fishing catch and effort.

The Academies' Ocean Studies Board will host two additional regional meetings. Details still need to be finalized, but one meeting is planned for New Orleans, Louisiana from May 26-28 (tentative dates) and the other is planned for Irvine, California from July 11-13 (also tentative dates).
