IMPORTS AND EXPORTS OF FISHERY PRODUCTS ANNUAL SUMMARY, 2013

IMPORTS

U.S. imports of edible fishery products in 2013 were valued at \$18.0 billion, up 8% from 2012. The quantity of edible imports was 2,458,757 metric tons, an increase of 16,813 tons (1 percent) from the quantity imported in 2012.

The volume of shrimp imported in 2013 was 507,382 tons, a decrease of 26,335 tons, or 5 percent, from the quantity imported in 2012. Valued at \$5.3 billion, shrimp imports accounted for 29 percent of the value of total edible imports. Imports of fresh and frozen salmon were 280,680 tons valued at \$2.4 billion in 2013. Imports of fresh and frozen tuna were 162,395 tons, about the same as in 2012. The value of fresh and frozen tuna imports decreased by 9 percent to \$973 million. Imports of canned tuna were 158,411 tons, about the same as 2012. The value of canned tuna imports also remained steady at \$765 million. Imports of all fresh and frozen fillets and steaks amounted to 697,408 tons, an increase of 31,921 tons from 2012. Total edible imports consisted of: 2,067,604 tons of fresh and frozen products valued at \$15.7 billion; 309,806 tons of canned products valued at \$1.8 billion; 42,406 tons of cured products valued at \$292 million; 2,680 tons of caviar and roe products valued at \$32 million; and 36,261 tons of other products valued at \$215 million.

Imports of nonedible fishery products were valued at \$15.1 billion, \$704 million more than in 2012. Total value of edible and nonedible fishery imports was \$33.2 billion in 2013, \$2.0 billion more than in 2012.

EXPORTS

U.S. exports of edible fishery products of domestic origin in 2013 were 1,455,706 tons valued at \$5.19 billion, compared with 1,426,894 tons valued at \$5.12 billion exported in 2012.

Exports of fresh and frozen items were 1,333,554 tons valued at \$4.3 billion, an increase of 36,953 tons and an increase in value of \$14.3 million compared with 2012. Fresh and frozen exports consisted principally of 186,023 tons of salmon valued at \$620.0 million, 45,662 tons of lobster (*Homarus spp.*) valued at \$501.1 million, and 173,507 tons of surimi valued at \$388.4 million. Exported canned items totaled 62,619 tons valued at \$306.9 million. Salmon was the major canned item exported, with 45,467 tons valued at \$228.7 million. Cured items accounted for 6,163 tons of exports valued at \$20.0 million. Caviar and roe exports were 41,940 tons valued at \$459.1 million. Other edible products accounted for 11,430 tons valued at \$62.0 million.

Exports of nonedible products were valued at \$17.8 billion. Exports of fish meal amounted to 148,555 tons valued at \$184.5 million. The total value of edible and nonedible exports was \$23.0 billion, \$593 million more than in 2012.

RE-EXPORTS

U.S. exports of edible fishery products of foreign origin in 2013 were 52,285 tons valued at \$386.0 million, compared to 49,061 tons valued at \$347.1 million re-exported in 2012. Fresh and frozen items were 47,126 tons valued at \$343,380 million. This reflects increases of 3,546 tons and \$37.7 million compared with 2012. Shrimp (2,604 tons valued at \$27.7 million), salmon (11,912 tons valued at \$96.9 million), crabs (951 tons valued at \$14.7 million) and tuna (2,659 tons valued at \$10.8 million) were the principle fresh and frozen products re-exported. Canned items accounted for 2,652 tons valued at 16.1 million. Cured products were 419 tons valued at \$4.4 million. Caviar and roe re-exports were 711 tons valued at \$10.6 million. Other edible products were 1,377 tons valued at \$11.6 million.

Re-exports of nonedible fishery products were valued at \$5.8 billion. Fish oils accounted for 2,936 tons valued at \$14.5 million. The total value of edible and nonedible re-exports was \$6.2 billion, \$1.3 billion more than in 2012.

NOTES:

Unless otherwise noted, the information presented is based on U.S. Census Bureau data for the Customs territory of the United States. The territory includes the 50 states, District of Columbia, Puerto Rico, and the U.S. Virgin Islands.

Imports for consumption are a combination of entries into the U.S. for immediate consumption and withdrawals from Customs bonded warehouses for consumption. These data reflect the actual entry into U.S. consumption channels of commodities that originated outside the United States.

Exports may include merchandise of both domestic and foreign origin. Census defines exports of “domestic” merchandise to include commodities, which are grown, produced, or manufactured in the United States. For statistical purposes, domestic exports also include commodities of foreign origin which have been changed in the U.S. from the form in which they were imported, or which have been enhanced in value by further manufacture in the United States.

Re-exports of “foreign” products are commodities which have entered the U.S. as imports and not sold, which, at the time of re-export, are in substantially the same condition as when imported. Items imported for sale in the U.S. but later resold overseas, however, are recorded as exports of domestic goods rather than as re-exports.

A product of foreign origin is transformed into a domestic good when the imported item loses its foreign identity through further substantial manufacturing. This transformation generally produces a good with a different trade classification. For example, fish sticks cut from imported fish blocks, when exported to a foreign country, are classified as domestic for statistical purposes.

The value of imports presented is the “Customs value.” It is based on the value of the product in the country of origin as appraised by the U.S. Customs and Border Protection, and excludes import duties, freight, insurance, and other charges incurred in bringing it to the United States. Export and re-export value is equivalent to f.a.s. (free alongside ship) at the port of export, based on the transaction price, including freight, insurance, and other charges incurred in placing the merchandise alongside the carrier. The value excludes the cost of loading, freight and subsequent insurance.
